

## 2012 50<sup>th</sup> Wine Week Drawing Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN.** Void where prohibited. A purchase will not improve chances of winning.

GRAND PRIZE DETAILS: There will be one Grand Prize winner consisting of a Weekend Getaway Trip for 2.
